1	<i>Terminal Access charges will be levied @ Rs 1,60,000/-per rake for inward and outward movement. (Leviable wheather rake in & out with empty / loaded container or Flat rake)</i>	
2	<i>If the TXR of rake is done at ALIK than TXR charges of Rs 22,500/- per rake will be charged for the same.</i>	
3	<i>Stabling charges of Rs 500 per day per wagon will be charged for stabling of rakes.</i>

Terms and Conditions

1. The rates are valid till further notice.
2. For any mis-declaration of cargo weight inside the containers, the customer will be liable to any amount of penalty levied by Indian Railways.
3. Container will be sealed by Customer by putting his own seal at loading factory.

4. Rates are Exclusive of service tax and customer agrees to pay the service taxes as applicable.
5. Customer has to provide necessary document like Form 6 for timely despatch from Mundra to Container terminal.
6. Payment Terms : Through PD Account / with in 24 hrs of Rail out / Before delivery at destination terminal.

7. The customer shall take comprehensive insurance policy for the cargo and containers. In case of any damage loss to cargo during rail transit, the liability of ALL will be in accordance with the Concession Agreement.
8. In case of Dispute, the courts at Gurgaon shall have exclusive jurisdiction.
9. Customer will pay Railway Infrastructure Development Charges (RIDC), Port Handling charges etc; such charges are not a part of this Tariff.
10. The rates may be modified before end of validity in the event of a hike in diesel price or Indian Railways haulage rate.
11. ALL shall have lien (general/specific) over the consignment entrusted by the Customer for transportation in respect to any amount due to it towards any service rendered or proposed to be rendered by ALL.
12. For the 40' containers *For the Cargo Not coming under Notified commodities (Refer. Railway circular No RC-30, dt-29.10.2010)* as the rates are heavily discounted so the payment has to be given through cheque or RTGS before rail out of the containers.
13. For hazardous/Reefer/Tank containers the rates are 25% more than the normal THC.
14. For ODC consignments the rates are 50% more than the normal THC.
