Sub: Express corridor for movement of Medical oxygen and related equipment for CoVID-19 relief activity through MIDPL (Kattupalli Port) & Adani Ennore Container Terminal in Kamarajar Port - Reg

In view of the current oxygen shortage across the country as a result of the unprecedented Covid-19 pandemic, Adani Ports & SEZ Ltd would like to initiate an express corridor service for the movement of Medical oxygen and related equipment (medical grade oxygen, raw materials, oxygen tanks, oxygen bottles, portable oxygen generators, oxygen concentrators, steel pipes for manufacturing oxygen cylinders etc.) for CoVID-19 relief activity.

Shipping Lines & Agents intending to move their consignments, carrying the abovesaid cargo through Kattupalli port and Adani Ennore Container Terminal in Kamarajar Port are requested to furnish the below details prior to the vessel departure from the previous port or three days prior to the arrival of the consignment (whichever is earlier).

- 1. Shipping line through the VOA (Vessel Agent) to declare the priority container list to avail the service.
- 2. IAL of the priority cargo along with B/L details, BE details, consignor details and evacuation details.
- 3. Stowage location it is preferred that the container is over stowed and should be available for first pick on commencement of operations.

Upon berthing of Vessel at the Port, Shipping Line shall arrange the below

- 1. Trailer for evacuation (in case of road delivery) along with the relevant Customs / statutory clearance documents. Container shall be loaded directly on to the trailer and Port security shall escort the consignment out of the port premises.
- 2. In case of containers to be evacuated by rail from AECTPL @ Kamarajar Port, the respective CTO shall simultaneously place the rake or have the consignment planned on the first available rake. Train placement shall also be declared in advance to facilitate this transit on priority.

The above details shall be sent to the below Operations / Marine team and Customer Service contact where the vessel is declared to call.
